i. Report of Grant Committee and Discussion

1. Grant committee met to decide what their next steps would be
2. Committee included: Derek Chin, Judge Duffin, Bryan Baker, Michael Stout, Chelo Guerrero
3. Unanimously agreed that the counsel should appoint a committee of 5-8 people to lead the grant committee and shepherd the grant request process and the people on the report are willing to participate in that. They would be charged with identifying needs for grant requests, including contacting individual agencies or entities to seek their needs.

3. David Borunda, Third District Court CEO [5 minutes]

- a. ***Pretrial services:*** There is a push to set up 24-hour monitoring and want to implement this statewide. The plan is to start this in Dona Ana County, hopefully within the next 60 – 90 days.
 - i. ***Samantha Woodward:*** Pretrial Services is trying to establish a warrant distribution process for the afterhours portion of monitoring. Hopefully they will have a start date soon.
- b. ***Legislative Session Updates:***
 - i. March 9 is deadline for governor to sign bills. House Appropriations will be conducting virtual hearings.
 - ii. ***Michael Stout:*** How could the role of the counsel be improved with the legislative process? The counsel could talk about things they agree on and could spend money on during the next legislative session.
 - iii. ***Judge Cano:*** There is no prohibition on reaching out to representatives/legislators in Dona Ana County to speak to them. We should remind them of our needs.
