1. *Approval of January Minutes*

- Michael Stout moves to approve the January minutes
- Judge Arrieta seconds the motion

2. *Genevieve Grant & Darla Goar, Judicial Information Division*

- *DataXchange presentation*
 - DataXchange is a way for justice partners to facilitate sharing information between agencies
 - Currently in phase 2 of the project and are looking for feedback from justice partners about what kind of data they would like to see on the platform
 - Justice partners can view data on the platform itself, ingest it to another application, or export it to a program like Microsoft Excel
 - No documents available on DataXchange – justice partners would use SOPA to get actual copies of pleadings
 - Law Enforcement agencies can use DataXchange to see all their upcoming hearings

3. *Robert Milks, NCIC Coordinator*

- *Electronic Warrants*
 - Electronic warrants have been working well.
 - MVRDA dispatchers don't facilitate the signing of the warrant.
 - There are concerns about warrants not getting emailed in a timely way and therefore the warrant gets re-entered and MVRDA would need to be contacted to have it removed.
 - Robert Milks asks for agencies send warrants (especially the after-hours warrants) directly to MRVDA for entry into NCIC
 - Email: ncic@mvrda.org; the email is monitored and they will acknowledge that the warrant has been received. If it is

supposed to go to a different agency then they will reply that the warrant needs to be sent to the correct agency.

4. *David Borunda, CEO*

- *Legislative Information*
 - a. Legislative session to end on March 20.
 - b. House Bill 2 and House Bill 117:
 1. Count has had to maintain a high vacancy rate to avoid furloughs
 2. This affects justice partners because the work can't be processed as quickly as usual.
 3. HB 2 recommends higher amount than a flat budget, and a flat budget would be the worst-case scenario.
 4. HB 117: Section 5 → 2% increase for all district and magistrate court judges; Section 8 → 60 million for 1.5% increase for all legislative, executive, and judicial employees

5. *Membership reports/announcements*

- *Judge Arrieta*: Grand Juries have been approved to resume; Pre-trial services will be expanded; may start diminishing COVID restrictions in the future
- *Kristofer Knutson*: Public Defender's office still not open to the public and is taking their cue from the courts
- *Paul Brock*: officer is recovering from incident earlier in the week
- *Sheriff Kim Stewart*: read Senate Bill 227 and give input
- *Michael Stout*: there should be a future legislative committee to evaluation legislation during the legislative sessions
- *Chelo Guerrero*: many pleadings are not in Spanish and how can the committee help with that?
- *Joel Diemer*: requesting time for presentation at next meeting regarding Behavioral Health Services
- *Mary White*: the Mobile Crisis Unit will be sending a RFP out soon
