1. Approval of July Minutes

2. David Borunda, CEO Third Judicial District Court

- Budget Updates
 - Operating budgets submitted for FY23
 - Preparing for start of legislative session and will first present in early November and then the legislative session in January.
 - Potential new positions that would apply to CJCCs in New Mexico (hasn't been approved, but is being requested)
 - Michael Stout: this should be put on future agendas for discussion. The purpose of CJCC is to find appropriate grant money to help the community and they might need to get a grant request in front of the sentencing commission.
 - District Court Annex – in the process of reviewing final architectural design for the building which could have a second floor for the District Attorney's office
 - Gerald Byers: requests that the DA's office be included in any future discussion about moving them
 - David Borunda: will most definitely involve the DA's office

3. Joel Diemer, Behavioral Health

- Initial Working Group Recommendations for Sequential Intercept Model Implementation
 - Judge Duffin tabled this item and it will be set for the October agenda for Judge Arrieta's return

4. Kristoger Knutson, Public Defender

- Probation Violations/Order Revoking Probation
 - a.* The issue has been resolved with Mr. Byers
 - b.* Probation Violation Orders generated by the DA's office were not being created timely
 - c.* Gerald Byers: agrees with Mr. Knutson and acknowledges that the DA's office has worked toward resolving the issue
