This Packet contains instructions and court forms to file a Motion for Custody and Time-Sharing in your child support case.

Use this packet if:

- There is a court case filed against you for child support
   AND
- Human Services Department and the other parent of the child(ren) are the petitioners in that lawsuit.

These are basic, fill-in-the-blank forms - they do not deal with every situation.

Representing yourself PRO SE (without a lawyer), means you are expected to **know the law**, prepare and file pleadings and present your case just like a lawyer is required to do.

Court Staff *can* tell you about court procedures, rules, records, and forms.

Court Staff <u>cannot give legal advice</u> about your rights or responsibilities. They <u>cannot</u> fill out these forms for you and they cannot tell you if you have properly presented your case.

- Type or print in black ink
- Fill out all blanks and check all boxes that apply.
- If there is not enough room on the form, write your information on another sheet of paper and staple the paper to the form.
- DO NOT write on the back of any page.

- The courthouse is open from 8-Noon and 1-5 Monday-Friday.
